No guests of Musician/s are permitted without the consent of the Purchaser.

The Purchaser shall at all times have complete supervision, direction, and control over the services of the Musician/s on this engagement and expressly reserves the right to control the manner, means, and details of the performance of the services by Artist as well as the ends to be accomplished within reason and within the definition of this contract.





15. The agreement of the Musician/s to perform is subject to proven detention by sickness, accidents, riots, strikes, epidemics, acts of God, or any other legitimate conditions beyond their control. If the Musician/s is unable to perform, Musician/s will take reasonable measures to provide a suitable alternate musician.
